

## **PDT MACRON ANNOUNCES 3 LEVELS OF EASING THE LOCKDOWN FROM 28 NOVEMBER**

### **CURFEW REPLACES LOCKDOWN ON DECEMBER 15**

**USPA NEWS** - The President of the French Republic, Emmanuel Macron, announced this evening at 8: pm, during the Journal televise in Prime Time on the TV channel, Tf1, the reduction of the current containment measures (It had started on October 30, 2020), for deal with the second wave of COVID-19. Thus the President of Macron, addressed the French by announcing three chronological and gradual stages from November 28 to January 15: extension of confinement with nevertheless the reopening of so-called "non-essential" businesses, such as bookstores, clothing stores, as well as real estate agencies, hairdressing salons, and home interventions, under a strict sanitary protocol.

The outdoors, delay will be relaxed, on the authorization to go out for a 20km walk, form 1 hour to 3 hours per day. (instead of the 1 hour / 1 kilometer rule, previously). From Saturday 28th November, the certificate will allow you to travel 20 km from home, instead of 1, and for three hours instead of one. confinement remains in force) and the trips from region to another shall be allowed. The exit certificates will always be required by the police and with respect for health barriers and of course the wearing of the compulsory mask. From December 15 the confinement will be lifted, but, under a curfew will be implemented from 9 p.m. to 7 a.m., "if the health objectives are reached", explained the Head of State Macron, He explains that the December 15, travel can be done without authorization, including between regions, and "spend Christmas with the family". Restaurants and cafes will be reopened on January 20 if the sanitary situation allows. However, "unnecessary travel" will be limited. A national curfew is to replace the lockdown, (If confinement is lifted) from 9 p.m. to 7 a.m. will be established, with an exception for the evenings of December 24 and 31 when traffic will be free. The Head of State ended his speech by announcing the next vaccinations, which could begin "at the end of December, beginning of January for the vaccine" for "the most fragile people", "subject to validation by the health authorities", and reassured the Head of State on vaccination "It would not be mandatory." Prime Minister Jean Castex, meanwhile, will give a press conference on Thursday, November 26, in the morning, in order to detail the easing of confinement announced Tuesday by the President of the Republic, Emmanuel Macron.

### **THE 3 LEVELS OF THE LIGHTNING OF THE CONTAINMENT MEASURES ANNOUNCED BY PDT MACRON-----**

Three levels to lighten the confinement. If deconfinement is not for now, the Head of State foresees three deadlines to lighten the confinement: a first on November 28, with in particular the Containment will be lifted on December 15, added Emmanuel Macron. Finally, in January, with a virtual return to normal. Sports halls and restaurants will be able to reopen on that date "if possible", he announced.

### **NON-FOOD SHOPS HAIRDRESSERS & HOME WORKERS ARE REOPEN FROM 28 NOVEMBER-----**

Non-food businesses, hairdressing salons, real estate agencies, booksellers, record stores, will be covered from November 28th. Bars and restaurants, discotheques, nevertheless remain closed during the period of confinement. The hotels are already open during the confinement period. Companies that will remain closed will receive financial assistance of 20% over the year 2019, of their turnover or 10,000 euros "in compensation for their losses, linked to the lockdown.-----

### **NEW YEAR'S EVE & CHRISTMAS TO BE CELEBRATED IF THE CONTAMINATIONS DROP TO 5000-----**

If the number of contaminations drops to 5,000 per day with around 2,500 to 3,000 people in intensive care, the French will spend the end of year celebrations with the whole family. explained the head of state Macron who is considering a "lifting of confinement" on December 15. The French will then be able to move without authorization, including between regions, and "spend Christmas with the

family". However, "unnecessary travel" will be limited. From December 15, a national curfew from 9 p.m. to 7 a.m. will be implemented, to replace confinement. In case of lifting of confinement, with an exception for the evenings of December 24th of Christmas and 31 for new year's evening, when traffic will be free.

VACCINATION SHALL BE PUT IN PLACE BY THE END OF DECEMBER BEGINNING JANUARY HAS ANNOUNCED THE PDT MACRON-----

The Head of State Macron knew his speech by giving an appointment "at the end of December, beginning of January for the vaccine", for the period of vaccination, "would not be compulsory" and it could begin "from the end of December, the beginning of January "for" the most fragile people ", " subject to validation by the health authorities ", tempered President Macron. President Macron also encouraged the French to download the STOP COVID-19 application on their smartphone.
